Sam's Story

After Sam's mom passed away when he was 13, he traveled hundreds of miles to live with his dad who, simultaneously, got hurt in a workplace accident and was fired while recovering.

Sam's dad had enough saved to get by for a while, but eventually the savings began to run out. Despite living on nothing but peanut butter sandwiches for weeks to save money, they were being faced with eviction. By the time Sam and his dad found out about Friends In Deed they were terrified, deeply embarrassed, and desperate.

But Friends In Deed welcomed the opportunity to help them keep their home through our Homelessness Prevention Program. And although they still really like peanut butter, the Food Pantry has helped them add a lot more variety to their diets! The best news though, is that Sam's dad has a new job and Sam has the stability and comfort he so desperately needs after losing his mom and making a big move.

The joy of having a door

Tim, the Food Pantry Director, writes: "Joy and gratefulness sometimes come in ways we can't quite fathom. I just experienced this while speaking with a mid-30s man who came into our pantry for food.

It was his first visit in a number of years. I asked him where he lived. He paused for a second and then said 'I have a door.' He had been homeless. I must have looked perplexed because he continued 'I have a refrigerator, a microwave, and a place to put my things.' From the rest of what he told me, his home wasn't what most of us would consider a home. But he



could sleep sheltered from the elements, didn't have to worry about his things being stolen, and no longer had to carry his belongings with him wherever he went.

He was ecstatic and you could see it radiating from him as he spoke. As he got up to leave, he told me that he was getting prepared for a job fair next week that he had heard about. The same enthusiasm and joy were in that statement too."



Linda's Story, Part II

In the last newsletter we told you about Linda, a Women's Room client who is slowly recovering from years of abuse. Her confidence has now grown to the extent that she is able to confide not just in Jane (TWR Associate), but also in our TWR case manager, Denisse. Her grief for her husband is still extremely strong, but Denisse is working with her on this, and Linda is also seeing a therapist. With the patient, consistent, long-

term help of the TWR staff, Linda is really beginning to open up and heal.

Linda expresses herself by writing heartfelt cards to the staff who help her. Jane received one some months ago; now Denisse has one too, proudly displayed on her bookcase.

Never underestimate the power of a manicure to make someone feel good!

Ellen has been volunteering in The Women's Room since 2012. She first started doing manicures as a hobby, but then discovered the joy of doing them for the ladies in The Women's Room. Now, every month, Ellen can be found at Friends In Deed House, giving her ladies elegant, brightly colored, glossy nails.



But there's another, more profound, aspect to what she does. Often, while she is working on their nails, her ladies start to talk about their lives. Ellen says she gives "an ear to listen, not to judge or anything of that nature," but just to listen.

The TWR ladies talk about how "marvelous" it feels to get their nails done, how it "feels awesome" to have clean, trimmed nails, how they "enjoy it so much." But Ellen talks about the joy of giving, saying it's better to give than to receive. She loves it when someone gives her a hug, tells her she's "never had a

manicure before," and leaves with a smile on her face.

Cynthia

After Cynthia retired she looked for a volunteering opportunity in which she could help people. She was thinking about finding a food pantry to help in, but when she checked our website she saw The Women's Room needed volunteers to help with laundry and showers.



There's nothing more basic, Cynthia says, than helping someone to be clean and to have clean clothes. The client feels better at once. "It's very satisfying," she told me.

What moves Cynthia about the women in The Women's Room is their strength and resilience – and how grateful they are for the help we give.



Kay

Kay got involved in Friends In Deed through her church. At first it was through one-off projects like shelf stacking in the pantry, but she decided she wanted more regular involvement and now helps in The Women's Room once a month. One of the things she appreciates about this is the way in which Marlene enabled her to tailor her commitment to the time she has available.

Kay feels we "all need to stay in touch with people who are experiencing challenging times." She feels that working in The Women's Room makes her more aware and more understanding, and she talks about

how courageous, smart, and determined the guests can be. One in particular sticks in her mind - a very young woman, recovering from abuse, who was working nights at Dodger Stadium and still managing to make it to The Women's Room during the day, and who was determined to move on to a better job in the future.
