


Weekly Message

Dear Friend,

Jessica grew up in the San Gabriel Valley and, like many, she married and raised a family with her husband. Unfortunately, about 15 years ago, her husband developed pancreatic cancer and passed away soon after.

Jessica moved in with her mother-in-law, but her mother-in-law also passed, leaving Jessica a homeless senior. She qualified for a Section 8 voucher and for a couple of years was able to keep herself in housing until the multiple bereavements of the previous years caught up with her. She suffered a mental breakdown and lost her home. She couch surfed for a while but exhausted the goodwill of friends and family, and began living in her car with her dog.

Friends In Deed was able to get Jessica's Section 8 voucher reinstated and ported to LA County. Finding housing was a very, very long process - even with the voucher and the support of FID she was continually rejected because of her credit score. Finally, however, Housing Navigator William's diligent searching paid off and we were able to move Jessica into a senior living facility in Duarte.

This week, I have our last honoree to highlight for our <u>Jazz, Encore!</u> fundraiser, which is next week! Lisa and Scott Nelson are being honored with Special Volunteer Recognition for their tireless efforts in the Food Pantry. I asked Tim, our Director of the Food Pantry, to share his thoughts about Lisa and Scott. Here are his words:

"I've been in charge of the Food Pantry for almost 10 years and I don't remember exactly when or how Scott and Lisa found us. It has been that long since they first knocked on the Food Pantry door looking to see if we could take the donations they had in their truck. I said sure, and, after unloading, they asked how they could help. I wasn't exactly sure right then, but we exchanged numbers and I told them I would reach out when we needed some help. Well, it wasn't too long before I asked them about picking up donations from a local grocery store. They said yes and started doing the pick up a couple of times per week. From there, their service involved bringing bread donations which turned into filling in for our volunteers who would pick up from the LA Food Bank.

Currently, Scott and Lisa pick up two times per week from Trader Joe's (more if necessary) and go down to the LA Food Bank for a produce pick-up. Whenever there is a donation pickup I need help with, I call Scott and Lisa. I've probably called them too often, but they would never admit to that. And that is part of what makes them such wonderful people. Scott and Lisa are people that are just "built" with the desire and dedication to serve. And it isn't just for Friends In Deed. They helped start the PCC Food Pantry (and they still help out there). They take food to The Salvation Army and downtown LA. They've helped our friends over at PazNaz Church with pickups and donations. Serving and helping are just a part of who they are. And our community is richer for it.

As I mentioned, I don't remember the exact reason why or when they came to Friends In Deed, but I am sure glad they did. The Friends In Deed motto of "doing together what we cannot do alone" rings true in our relationship. We have been able to provide so much more food to our community because they have been here to help us. I am honored to know them, work alongside them in the fight against hunger, and to be able to call them my friends. Scott and Lisa Nelson are some of the finest people I've ever met."
