Dear Friend,

As I have shared many times, the best solution to solving homelessness is to not let people become homeless in the first place. Contrary to popular belief, mental illness, addiction, poverty or local politics are not the main reason cities have higher or lower rates of homelessness. Rather, the high cost of housing, and lack of available affordable housing, is the main driver (see the book <u>Homelessness is a Housing Problem</u>). And yet, sometimes, even if a family has stable housing, there are moments that can cause a spiral leading toward eviction. Here is just one family, among the hundreds that have called for assistance so far this year, that we have been able to help.

Danielle contacted EPRA (our Eviction Prevention and Rental Assistance program) at the end of January, seeking rental support. She and her husband Oscar were a young couple with two small children. Oscar was the only income earner at the time. He had been suffering from severe depression and had used up all his sick leave with his employer. He ended up taking an additional two months of unpaid leave to get healthy. As a result, the family fell behind on two months rent.

EPRA was able to pay off the arrears and provided two additional months of current rent to give the family an opportunity to get back on their feet. Since the children were now old enough to attend school, Danielle was able to look for work during the time that EPRA provided rental assistance. She recently called Marlene, our EPRA Assistant Director, with an update that she had secured employment. Friends In Deed's rental assistance offered this young family a way to manage their employment, and family life, so that both spouses can contribute income.


