

Weekly Message

Dear Friend,

Marcia was still reeling from the loss of her mother when her world seemed to collapse. The two had shared a modest one-bedroom apartment, splitting the rent to make ends meet. After her mother's sudden passing, Marcia found herself not only grappling with the grief of her loss, but also facing the heavy burden of funeral arrangements. With no other family to turn to and bills piling up, she quickly fell behind on rent.

As if things weren't bad enough, Marcia was then laid off from her job. Due to a previous layoff from another job, she didn't qualify for unemployment benefits. The weight of it all – grief, financial struggles, and the uncertainty of her future – became overwhelming. Marcia had managed to secure a new job, one that would eventually allow her to stay on top of her rent, but she was too far behind to catch up on her own.

When Marcia reached out to Friends In Deed and the Eviction Prevention and Rental Assistance (EPRA) program, the team provided her with three months of rental assistance, covering the debt that had accumulated during her time of crisis. They even provided an additional month of support, giving Marcia a small savings buffer as an extra layer of protection to help get her back on track.

With the immediate crisis averted, Marcia could finally breathe again. Thanks to Friends In Deed, she didn't just avoid eviction; she regained rent stability and the chance to rebuild her life, free from the looming fear of homelessness.

It is for people like Marcia that we raise funds; for the hundreds of individuals that come through our Food Pantry doors, each with their own story to tell; for each unique soul that has found themselves unsheltered, living on the streets, each with a story to tell; and we do our best to tell as many of them as we can so that YOU feel moved, inspired and motivated to support us. This is what we are starting to call "mission-based fundraising." This is not only a term, but a philosophy of how to approach <u>raising the necessary funds</u> to do our work. It is why we have started to have events like Cooking for a Cause and Stories from the Street, rather than a gala or other fundraisers that don't distinguish us from other organizations in terms of our mission. You will begin to hear these ideas from me on a more regular basis, as we seek to transform our development work into more of a "culture of philanthropy."



Finally, election day is almost upon us and there is an important measure on the ballot that directly relates to our work. Measure A is an initiative that will replace Measure H, thereby enabling the necessary funding to continue supporting the work of all agencies in our field, as Measure H is set to expire in 2027. 


