Dear Friend,

Margot's life changed when her mother's health took a sharp decline. In her early 40s, Margot was self-employed and worked remotely to keep up with expenses. When her mother, now in her late 70s, needed full-time care, Margot didn't hesitate: she moved in with her mother, becoming her sole caregiver.

The responsibilities of caregiving quickly took over Margot's life. With her mother's worsening condition, there was little time left for work. Balancing rent, bills, and medical expenses became impossible, and the strain of losing her income weighed heavily on Margot. As the months passed, she fell behind on rent and deeper into debt. She soon found herself in a crisis with no steady source of income.

Desperate to find a solution, Margot contacted Friends In Deed's Eviction Prevention and Rental Assistance (EPRA) program. Stressed and overwhelmed, she wasn't sure how she would keep her home or provide for her mother. EPRA provided the funding to pay off the arrears she owed and thus avoided an eviction. We also provided her with advice on budgeting and creating a financial plan, and assisted her in the process of applying to become her mother's paid caregiver, ensuring a future source of income for the both of them.

Margot's story is becoming more familiar to our staff: a single adult trying to manage their own life and finances while caring for an aging parent. Thanks to Friends In Deed, Margot found not only the financial help she needed but also the support to navigate this difficult chapter of her life. With a plan in place, she can focus on caring for her mother and maintaining their home.

Thank you to everyone who continues to <u>support us!</u> It is only with your help that we can be there for people like Margot, not only providing the necessary funds so she can keep her home, but also sharing the compassion and dignity that is the foundation of our mission.




